RESPONDING TO AN ALLEGATION OF SUSPECTED CHILD ABUSE

Procedures for Pastoral Response and Mandated Reporting of Any Allegation of Abuse or Neglect of a Minor.

REMINDER: Under federal and state law, mandated reporting is required when the victim is currently a

minor and/or if there is reason to suspect that the alleged abuser has access to minors. If the victim is not currently a minor but has experienced sexual abuse by clergy, employee or volunteer, get all the basic facts outlined below and call the Archdiocesan Victim Assistance Ministry Office (213) 637-7650 to make a non-mandated report and to arrange for outreach

for the victim.

LISTEN: First and foremost, listen compassionately, validate the courage of the person making the

report, and express regret for any pain the reporting person may be feeling.

GET BASIC Name(s), addresses (es), phone number(s) of the victim, the alleged perpetrator, the

FACTS: person making the report and witnesses (if available). Refer to the "Suspected Child Abuse

Report" (SCAR) form below. Compile these facts based on what is readily available.

Do not investigate incident.

AFTER REPORTING TO AUTHORITIES

Call Victim Assistance Ministry (213) 637-7650

When you call in the report, get the name /phone number of the person taking the Report, any

case number and the address for mailing the written Report.

CONSIDER: Ask the person or persons making the allegation, to join you when you call in the Report. If the

reporting person is an adult, encourage him or her to also report the allegation directly.

DOCUMENT: After making the Report by telephone, **complete either** a paper copy (SS8572)

http://oag.ca.gov/childabuse/forms of the "Suspected Child Abuse Report" or file it

electronically at https://mandreptla.org/on-lineRep.htm . If you use the paper copy, mail it to the

address you receive from the person you called to make the Report. All reports must be completed and submitted within 36 hours of receiving the information concerning the incident. If the Hotline or the Police decline to take the Report over the phone, ask for the name and ID or badge number of the person to whom you are speaking. Write this information, along with the note "declined to take Report" and the date and time of the call, on the Report

form. Ask for a supervisor if you feel the Report should not be declined.

Keep a copy of the Report for your records and SCAN or Email the electronic or paper copy of

the report to the Victims Assistance Ministry Office at hbanis@la-archdiocese.org.

OUTREACH: Call the Archdiocesan Victim Assistance Ministry Office (213) 637-7650 for information on counseling and other resources for the victim(s) and/or family, and the reporting person(s).

CONCLUDE: Offer reassurance, hope and continued support.
